
Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term. Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam incurred a loss after fund charges were deducted of \$1,978 (that is -19.78% of his initial \$10,000). Sam didn't pay any other charges. This gives Sam a total loss after tax of \$1,848 for the year.
