What is the purpose of this update?

Description of this fund

The Fund targets a portfolio of global companies with high total return potential and high ESG factor scores.


The Fund's investment objective is to outperform the MSCI World (Net) Index in New Zealand dollars on a rolling three-year basis.

Foreign currency exposures are not hedged back to New Zealand dollars.

What are the risks of investing?

Risk indicator for the Salt Sustainable Global Shares Fund


How has the fund performed?


Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term. Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$2,716 (that is 27.16% of his initial \$10,000). Sam didn't pay any other charges. This gives Sam a total return after tax of \$2,574 for the year.
