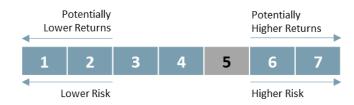
Description of this fund

The Fund's investment objective is to outperform the Reserve Bank of New Zealand's Consumer Price Index +5% p.a. benchmark on a rolling five year basis. The Fund targets a diversified mix of growth and defensive assets, with a focus on securities with strong ESG credentials.

What are the risks of investing?

Risk indicator for the Salt Sustainable Growth Fund

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term. Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$573 (that is 5.73% of his initial \$10,000). Sam did not pay any other charges. This gives Sam a total return after tax of \$444 for the year.
