
Description of this fund

The Salt NZ Dividend Appreciation Fund targets a portfolio of shares of New Zealand companies that may, in our opinion, pay high and sustainable dividends. A considerable body of robust research suggests that stocks with strong and sustained dividend policies tend to generate higher free cash flow than average and outperform their index benchmarks over time. The strategy is not intended to naively generate the highest possible yield but rather to generate a high and sustainable dividend yield.




Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term. Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$1,269 (that is 12.69% of his initial \$10,000). Sam didn't pay any other charges. This gives Sam a total return after tax of \$1,164 for the year.
